DELEGATION OF POWERS

Attached hereto is a copy of a new Regulation under the Veterans' Land Act, by which, pursuant to subsection 48(2) of the said Act, the Director amends the Delegation of Powers (VLA) Regulations, C.R.C., c.1588 by revoking the Schedule therein and substituting therefor a new Schedule.

Land Registrars are, therefore, advised that as a result, all instruments executed on behalf of the Director, the Veterans' Land Act bearing an execution date subsequent to September 23, 1982 may only be executed by one of the parties named in the revised Schedule.
