5. (1) Despite subsection 2 (1), the tax rates set out in Table 4 to this Regulation are prescribed for 2004 for the territories set out in that Table for the residential property class and the multi-residential property class, as prescribed under the *Assessment Act*.

(2) Despite subsection 2 (2), the tax rate equal to 25 per cent of the tax rate for the residential property class set out opposite the name of a territory in Table 4 to this Regulation is prescribed for 2004 as the tax rate for that territory for the farm property class and the managed forests property class, as prescribed under the *Assessment Act*.

2. The Regulation is amended by adding the following Table:

(2) Section 1 of the Regulation is amended by adding the following subsection:

(4) The tax rate for school purposes for 2004 for property in the farm property class or the managed forests property class, as prescribed under the *Assessment Act*, is 0.0740 per cent of the assessed value of the property.

2. Section 2 of the Regulation is amended by adding the following subsection:

(7) For 2004, the annual tax rate for school purposes for the purposes of section 257.7 of the Act for a municipality set out in Table 15 for the pipeline property class is the tax rate in the column entitled "Pipeline Property Class" in the Table set out opposite the name of the municipality.

3. (1) Subsections 3 (2) to (2.7) of the Regulation are revoked and the following substituted:

(2) The tax rates set out in the following Tables are prescribed as the tax rates for school purposes for the purposes of section 257.7 of the Act for the following years for the property classes prescribed under the *Assessment Act* in the territories set out in the Tables:

1. For 1998, Table 2.
2. For 1999,
 - i. Table 3 if the territory is listed in Table 3, or
 - ii. Table 2 if the territory is not listed in Table 3.
3. For 2000,
 - i. Table 3 if the territory is listed in Table 3,
 - ii. Table 6 if the territory is listed in Table 6, or
 - iii. Table 2 if the territory is not listed in Table 3 or 6.
4. For 2001, Table 9.
5. For 2002, Table 11.
6. For 2003, Table 14.
7. For 2004, Table 16.

(2) Subsection 3 (3) of the Regulation is amended by striking out "tax rates prescribed under subsections (2), (2.1), (2.2), (2.3), (2.4), (2.5), (2.6) and (2.7) are" and substituting "tax rate prescribed under subsection (2) for a year is".

4. (1) Subsection 9 (1) of the Regulation is revoked and the following substituted:

TAX RATES FOR BUSINESS PROPERTIES AFTER 2000

(1) This section applies with respect to business property, within the meaning of section 257.5 of the Act, other than land described in paragraphs 1 and 2 of subsection 315 (1) of the *Municipal Act, 2001*, as long as the business property is within a municipality or deemed by a regulation made under section 56 or subsection 58.1 (2) of the Act to be attached to a municipality.

(1.1) In this section,

"commercial classes" means the commercial property class prescribed under the *Assessment Act* and optional property classes that contain property that, if the council of the municipality did not opt to have the optional property class apply, would be in the commercial property class;

"industrial classes" means the industrial property class prescribed under the *Assessment Act* and optional property classes that contain property that, if the council of the municipality did not opt to have the optional property class apply, would be in the industrial property class;

"optional property class" means a property class that the council of a municipality opts to have apply in the municipality under regulations made under the *Assessment Act*.

(2) Subsection 9 (6) of the Regulation is revoked.**(3) Section 9 of the Regulation is amended by adding the following subsections:**

(8) For 2004, the annual tax rates for school purposes for the purposes of section 257.7 of the Act for a municipality set out in Table 15 are the following rates for the following classes of property:

1. For the commercial classes, the annual tax rate is the rate in the column entitled "Commercial Property Class" in the Table set out opposite the name of the municipality.
2. For the industrial classes, the annual tax rate is the rate in the column entitled "Industrial Property Class" in the Table set out opposite the name of the municipality.

(9) If there are two or more property classes in the commercial classes, the tax rate for school purposes for business properties in a property class in the commercial classes is determined by multiplying the 2004 tax ratio established for the property class under section 308, 309 or 310 of the *Municipal Act, 2001* by the weighted tax rate for the commercial classes determined as follows:

1. Determine the total revenue from the commercial classes by multiplying the applicable tax rate determined under subsection (8) by the sum of the assessments for all properties in the commercial classes other than,
 - i. properties defined in section 306 of the *Municipal Act, 2001* for which payments in lieu of taxes are made, and
 - ii. properties in the subclasses prescribed under paragraph 1 of subsection 8 (1) of the *Assessment Act*.
2. Determine the weighted assessment for each property class in the commercial classes by,
 - i. multiplying the assessment for each property in the property class by the 2004 tax ratio applicable to that property class, and
 - ii. finding the sum of all amounts each of which is an amount determined under subparagraph i in respect of properties in the property class.
3. Determine the weighted assessment for the commercial classes by finding the sum of the weighted assessments of the property classes in the commercial classes.
4. Determine the weighted tax rate for the commercial classes by dividing the total revenue for the commercial classes determined under paragraph 1 by the weighted assessment for the commercial classes determined under paragraph 3.

(10) If there are two or more property classes in the industrial classes, the tax rate for school purposes for business properties in a property class in the industrial classes is determined by multiplying the 2004 tax ratio established for the property class under section 308, 309 or 310 of the *Municipal Act, 2001* by the weighted tax rate for the industrial classes determined as follows:

1. Determine the total revenue from the industrial classes by multiplying the applicable tax rate determined under subsection (8) by the sum of the assessments for all properties in the industrial classes other than,
 - i. properties defined in section 306 of the *Municipal Act, 2001* for which payments in lieu of taxes are made, and
 - ii. properties in the subclasses prescribed under paragraph 1 of subsection 8 (1) of the *Assessment Act*.
2. Determine the weighted assessment for each property class in the industrial classes by,
 - i. multiplying the assessment for each property in the property class by the 2004 tax ratio applicable to that property class, and
 - ii. finding the sum of all amounts each of which is an amount determined under subparagraph i in respect of properties in the property class.
3. Determine the weighted assessment for the industrial classes by finding the sum of the weighted assessments of the property classes in the industrial classes.
4. Determine the weighted tax rate for the industrial classes by dividing the total revenue for the industrial classes determined under paragraph 1 by weighted assessment for the industrial classes determined under paragraph 3.

(11) For greater certainty in the application of subparagraph 2 i of subsection (9), if a municipality has passed a by-law opting to have the parking lot and vacant land class apply in the municipality, the assessment of a property that is vacant land, as defined in the regulations made under the *Assessment Act*, that would otherwise be included in a property class in the commercial classes is multiplied by the tax ratio for the parking lot and vacant land class and not by the tax ratio for the property class in which the property would otherwise have been included.

(12) For the purposes of subsections (9) and (10), the assessment of a property is the amount according to the assessment roll, as adjusted in accordance with subsections 311 (5) and 312 (5) of the *Municipal Act, 2001*, less the same percentage of the assessment as the percentage reduction, if any, under section 313 of that Act in the tax rate applicable to the property for the year.

5. The Regulation is amended by adding the following section:

13. Subsections 314 (4) and (6) of the *Municipal Act, 2001* and the regulations made under clauses 314 (5) (b) and (c) of that Act apply, with necessary modifications, with respect to the tax rates set out in Table 15.

1. Section 4 of Regulation 892 of the Revised Regulations of Ontario, 1990 is amended by adding the following subsections:

(5) Claims or conciliations for delayed closing or delayed occupancy made under section 17 for all homes with a date of possession on or after May 1, 2004 shall be made in accordance with the administrative procedures for delayed closing or delayed occupancy published by the Corporation.

(6) The fees payable by the vendor in connection with conciliations for delayed closing or delayed occupancy made under section 17 for all homes with a date of possession on or after May 1, 2004 are as set out in paragraph 6 of Schedule A.

2. (1) Subsection 4.1 (1) of the Regulation is revoked and the following substituted:

(1) This section and sections 4.2 to 4.6 apply, and section 4 does not apply, to all claims made in respect of homes with a date of possession on or after October 1, 2003, excluding,

- (a) claims made in respect of the common elements of a condominium project; and
- (b) claims for delayed closing or delayed occupancy made under section 17 in respect of homes with a date of possession on or after May 1, 2004.

(2) Subsection 4.1 (7) of the Regulation is revoked and the following substituted:

(7) Submission by facsimile transmission is effective on the day sent, whether it is a business day or not.

3. Section 4.5 of the Regulation is amended by adding the following subsection:

(1.1) This section applies to warranty claims made under section 17 in respect of homes with a date of possession between October 1, 2003 and April 30, 2004, both inclusive.

4. Section 5 of the Regulation is amended by adding the following subsection:

(0.1) Section 4 applies, and subsection 5 (2) and section 5.1 do not apply, to claims and conciliations for delayed closing or delayed occupancy made under section 17 for all homes with a date of possession on or after May 1, 2004.

5. Schedule A to the Regulation is amended by adding the following paragraph:
