BUDGET MEASURES ACT, 2005 (NO. 2)

- (a) April 30, 2006 as the day on which the following provisions of the *Budget Measures Act, 2005 (No. 2)*, c. 31 come into force:
- Sections 1, 2, 3, 4, 6, 8, 10, 11 and 12 of Schedule 18, which amend the *Pension Benefits Act*;
 - Subsections 6 (1), (2) and (3) and section 7 of Schedule 21, which amend the *Teachers' Pension Act*;
- (b) July 1, 2006 as the day on which subsection 6 (4) of Schedule 21, which amends the *Teachers' Pension Act*, comes into force.

- a) le 30 avril 2006 comme le jour où entrent en vigueur les dispositions suivantes de la *Loi de 2005 sur les mesures budgétaires (n° 2)*, chap. 31 :

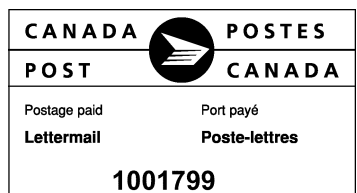
