- (a) September 30, 2008 as the day on which subsection 1 (4) of Schedule D to the *Health System Improvements Act, 2007*, c. 10, which amends the *Health Protection and Promotion Act*, comes into force; and
- (b) December 1, 2008 as the day on which the following provisions of Schedule D to the Act come into force:
 1. Subsections 1 (1) to (3) and (5) to (10), which amend the *Health Protection and Promotion Act*.
 2. Subsections 3 (1) to (8), (14) to (16) and (23) and (24), which amend the *Safe Drinking Water Act, 2002*.
