Statement by the Chief Electoral Officer  
Related to the Indexation Factor  
for the Five-Year Period 2009 - 2013

Pursuant to section 40.1, subsection 2 of the *Election Finances Act*, R.S.O. 1990, Chapter E.7, as amended, notice is hereby given of the statement of the indexation factor required by section 40.1, subsection 1, applicable to the five-year period from January 1<sup>st</sup> 2009 to December 31<sup>st</sup> 2013. The indexation factor was calculated based on the percentage change in the Consumer Price Index for Canada for prices of all items for the 60-month period ending October 31<sup>st</sup>, 2008 as published by Statistics Canada, rounded to the nearest two decimal points.

The indexation factor for the five-year period 2009 to 2013 will be 1.24.

Accordingly, the amounts provided in subsection 18(1), subsections 38(2), (3.1) and (3.4), subsection 40(7), and subsection 44(2) of the *Election Finances Act* are deemed to have been adjusted as follows:

## ORDER MADE UNDER THE MUNICIPAL ACT, 2001, S.O. 2001, c. 25

### TOWNSHIP OF GORDON, TOWNSHIP OF BARRIE ISLAND

#### DEFINITIONS

##### 1. In this Order,

"former municipalities" means The Corporation of the Township of Gordon and The Corporation of the Township of Barrie Island as they exist prior to January 1, 2009;

"former Township of Barrie Island" means The Corporation of the Township of Barrie Island as it exists prior to January 1, 2009; and

"former Township of Gordon" means The Corporation of the Township of Gordon as it exists prior to January 1, 2009; and "new municipality" means The Municipality of Gordon/Barrie Island created as a result of the restructuring under section 2.

#### MUNICIPAL RESTRUCTURING

2. On January 1, 2009, The Corporation of the Township of Gordon and The Corporation of the Township of Barrie Island are amalgamated as a single-tier municipality under the name "The Municipality of Gordon/Barrie Island".

#### COUNCIL

3. (1) Following the 2010 regular municipal election, the council of the new municipality shall take office on December 1, 2010 and shall be composed of five members consisting of,
  - (a) the head of council, to be known as the reeve; and
  - (b) four councilors,
 who shall be elected by general vote of the electors of the new municipality.
- (2) Each member of council shall have one vote.

#### INTERIM COUNCIL

4. (1) The terms of office of the council of the former municipalities elected in the 2006 regular municipal election shall expire on December 31, 2008.
- (2) The members of the interim council of the new municipality shall assume office on January 1, 2009, and shall hold office until November 30, 2010.
- (3) Effective January 1, 2009, the interim council of the new municipality shall be composed of seven members consisting of,
  - (a) the head of council, to be known as the reeve, who held office as the head of office of the former Township of Gordon;
  - (b) the four current councilors of the former Township of Gordon;
  - (c) the head of council of the former Township of Barrie Island; and
  - (d) the current councilor of the former Township of Barrie Island who acts in the place of the head of council when the head of council is absent.
- (4) Each member of council shall have one vote.

#### ASSETS AND LIABILITIES

5. On January 1, 2009, the assets and liabilities, rights and obligations, including employees, of the former municipalities and their local boards become the assets and liabilities, rights and obligations, including employees, of the new municipality.

#### ASSESSMENT ROLL

6. For the purpose of the preparation of the assessment roll for the new municipality under the *Assessment Act* for the 2009 taxation year, the former municipalities shall be deemed to be one municipality.

#### TAXES

7. All taxes, charges and rates levied, imposed or assessed under any Act by the former municipalities that are due and unpaid on December 31, 2008, shall be deemed to be taxes, charges and rates due and payable to the new municipality and may be collected by the new municipality in the same manner as if they had been levied, imposed or assessed by the new municipality.

#### RESERVES AND RESERVE FUNDS

8. Reserves and reserve funds shall become reserves and reserve funds of the new municipality and shall be used for the purpose for which they were designated on or before December 31, 2008, by the former municipality for the benefit of the ratepayers of the former municipality.

#### LIBRARY BOARD

9. Effective January 1, 2009, the council of the new municipality shall be entitled to appoint one member only to the Gore Bay Public Library Board.

#### BY-LAWS

10. (1) Every by-law and resolution of the former municipalities shall be continued and deemed to be a by-law or resolution of the new municipality and shall remain in force in the area of the former municipality until the date it is amended or repealed.
- (2) Any by-law of a former municipality passed under section 34 of the *Planning Act* or a predecessor of that section and any official plan of a former municipality approved under the *Planning Act*, or a predecessor of that Act, shall be deemed to be a by-law or official plan of the new municipality and shall remain in force until it is amended or repealed by the council of the new municipality.
- (3) If a former municipality has commenced procedures to enact a by-law under any Act, or adopt an official plan or amendment to it under the *Planning Act* and that by-law, official plan or amendment is not in force on January 1, 2009, the new municipality may continue the procedures.

#### DISPUTE RESOLUTION

11. (1) If a dispute arises with respect to any issue arising out of the interpretation of this Order, any of the former municipalities may refer the matter in dispute for resolution through mediation.
- (2) If the dispute is not resolved through mediation, then the matter may either be referred,
  - (a) to arbitration, to be conducted in accordance with the provisions of the *Arbitration Act, 1991*, except as provided herein; or
  - (b) by agreement of all of the former municipalities, to the council of the new municipality for resolution.
- (3) Where a dispute is referred to arbitration under clause (2)(a), the decision of the arbitrator shall be final.
- (4) The costs associated with mediation or arbitration proceedings under this section shall be shared equally among the former municipalities.

**COUNTY OF OXFORD, COUNTY OF PERTH**

**TOWNSHIP OF EAST ZORRA-TAVISTOCK, TOWNSHIP OF  
PERTH EAST**

### DEFINITIONS

1. In this Order,

“annexed area” means the area comprised of the lands described in the Schedule to this Order;

“East Zorra-Tavistock” means The Corporation of the Township of East Zorra-Tavistock; and

“Perth East” means The Corporation of the Township of Perth East.

### ANNEXATION

2. (1) On January 1, 2009, the portion of Perth East described in the Schedule is annexed to East Zorra-Tavistock and will form part of Ward 1 of East Zorra-Tavistock.
- (2) All real property including any highway, street fixture, waterline, easement and restrictive covenant running with the land of Perth East located in the annexed area vests in East Zorra-Tavistock on January 1, 2009.
- (3) Assets and liabilities of Perth East and The Corporation of the County of Perth that are located in the annexed area remain the assets or liabilities of Perth East or the County of Perth, as the case may be.
- (4) Despite subsection (3), any litigation commenced prior to January 1, 2009, with respect to the annexed area remains the obligation of Perth East or The Corporation of the County of Perth, as the case may be.

### TAXES, ETC

3. (1) All real property taxes under any general or special Act levied and uncollected in the annexed area which are due and unpaid on December 31, 2008, shall be deemed on January 1, 2009, to be taxes, charges and rates due and payable to East Zorra-Tavistock and shall be collected by East Zorra-Tavistock.
- (2) On or before February 1, 2009, the clerk of Perth East shall prepare and furnish to the clerk of East Zorra-Tavistock a special collector's roll showing all arrears of real property taxes or special rates and charges assessed against the land in the annexed area up to and including December 31, 2008, and the persons assessed for them.
- (3) If Perth East has commenced procedures under the *Municipal Act, 2001* for the annexed area and the procedures are not completed by January 1, 2009, East Zorra-Tavistock may continue the procedures.

### ASSESSMENT

4. For the purposes of the assessment roll to be prepared for East Zorra-Tavistock under the *Assessment Act* for the 2009 taxation year, the annexed area shall be deemed to be part of East Zorra-Tavistock.

### BY-LAWS

5. (1) On January 1, 2009, the by-laws of East Zorra-Tavistock extend to the annexed area and the by-laws of Perth East cease to apply to such area except,
  - (a) by-laws of Perth East,
  - (i) that were passed under section 34 or 41 of the *Planning*

*Act* or a predecessor of those sections; and  
(ii) that were passed under the *Highway Traffic Act* or the *Municipal Act, 2001* or a predecessor of those Acts that regulate the use of highways by vehicles and pedestrians and that regulate the encroachment or projection of buildings or any portion thereof upon or over highways,

which shall remain in force until amended or repealed by the council of East Zorra-Tavistock;

- (b) by-laws of Perth East passed under sections 45, 58 or 61 of the *Drainage Act* or a predecessor of those sections;
  - (c) by-laws of Perth East passed under section 10 of the *Weed Control Act*;
  - (d) by-laws of Perth East passed under the *Development Charges Act* which shall remain in force until repealed by the council of East Zorra-Tavistock or expire under that Act; and
  - (e) by-laws conferring rights, privileges, franchises, immunities or exemptions that could not have been lawfully repealed by the council of Perth East.
- (2) If Perth East has commenced procedures to enact a by-law under any Act or to adopt an official plan or an amendment thereto under the *Planning Act*, and that by-law, official plan or amendment applies to the annexed area and is not in force on January 1, 2009, the council of East Zorra-Tavistock may continue the procedures to enact the by-law or adopt the official plan or amendment to the extent that it applies to the annexed area.

### DISPUTE RESOLUTION

6. (1) If a dispute arises with respect to any issue arising out of the interpretation of this Order, any of the former municipalities may refer the matter in dispute for resolution through mediation.
- (2) If the dispute is not resolved through mediation or the parties cannot agree upon the selection of a mediator, then the matter may be referred to arbitration, to be conducted in accordance with the provisions of the *Arbitration Act, 1991*, except as provided herein.
- (3) Where a dispute is referred to arbitration under subsection (2), the decision of the arbitrator shall be final.
- (4) If any municipalities that are subject to this Order are parties to a mediation under subsection (1) or an arbitration under subsection (2), the costs associated with the mediation or arbitration proceedings shall be shared equally among those municipalities.

### SCHEDULE

Part of Lot 22, Concession 5, in the Township of Perth East, formerly in the Township of South Easthope, in the County of Perth, described as follows:

COMMENCING at the south-west corner of the said Lot 22;

THENCE easterly along the southern limit of the said Lot 22, also being the limit between the Counties of Oxford and Perth, to the eastern Corner of PART 2, Plan 41R-2718;
