homemaking services to persons who are frail or who have a cognitive impairment and who require that such services be available 24 hours a day, whether on-site or not;

(2) Subclause 4 (b) (i) of the Regulation is revoked.

2. This Regulation comes into force on the later of April 1, 2011 and the day it is filed.
