Supplemental Information

- Amendments made to Ontario's Greenhouse Gas Reporting Program in 2015 required new report types in 2016 for the following prescribed activities: electricity importation, natural gas distribution and petroleum product supply. The data collected under these report types is contained in a separate spreadsheet titled "2016-2018 All GHG Activities".
- The values for each electricity importer, natural gas distributor and petroleum product supplier are not published because it could reveal commercially sensitive information.
- Electricity importers are required to submit reports but are not required to calculate emissions, with the exception of 2017, as prescribed by O. Reg. 390/18.
- Natural gas distributors and petroleum product suppliers were required to report emissions in 2016 and 2017. Due to regulatory amendments in 2019, emissions from natural gas distribution and petroleum product supply are no longer required to be reported. Voluntary reports for natural gas distributors in 2018 are included and aggregate emissions are available but may not be comparable with previous years. Voluntary reports for petroleum product suppliers are not available due to commercial sensitivity reasons.
