## MEMORANDUM

## **Re:** COVID-19 Pandemic: Home Oxygen Therapy Update

In response to the evolving situation regarding the COVID-19 pandemic, the Assistive Devices Program (ADP) will implement and reinstate a temporary policy to waive the requirement for applicants who are non-existing ADP clients to meet the Program's medical eligibility criteria for ADP-funded home oxygen therapy when:

- the applicant needs home oxygen therapy on a short-term basis due to a **confirmed or suspected diagnosis of COVID-19** by a physician; and
- the applicant does not meet the Program's medical eligibility criteria for ADP-funded home oxygen therapy but a physician or nurse practitioner, licensed to practice in the province of Ontario, has prescribed oxygen to allow the applicant to be monitored and cared for in their home.

## When submitting the application requesting funding assistance under this temporary policy, results from an arterial blood gas or oximetry study are not required.

On the *First Time Application for Funding Home Oxygen Therapy*, Section 2 (Devices and Eligibility), Confirmation of Applicant's Eligibility for Home Oxygen Funding, Diagnosis, the ADP-registered vendor must record COVID-19 on the application form under "Other Diagnosis".

When submitting the *First-Time Application for Funding Home Oxygen Therapy*, the ADP-registered vendor must submit the application form via fax at 1-888-222-8018.

Applicants approved to receive ADP-funded home oxygen therapy on a short-term basis due to confirmed or suspected COVID-19 can receive up to 90-days of funding. Similar to a previous temporary policy, if home oxygen therapy is required beyond the 90-day funding period, the client and/or vendor must submit the *Renewal of Funding Home Oxygen Therapy* application form for consideration.

The ADP will be monitoring the evolving COVID-19 pandemic situation and will notify ADPregistered vendors when this time limited temporary measure is no longer permitted or if ADP will implement additional temporary policies.
