This has been an extraordinary year, where health care professionals have been at the forefront of keeping us all safe. As a healthcare professional, thank you for all you do!

As the year comes to an end, we would like to share some SADIE highlights with you from 2020, as well as share what we have planned for the year ahead and beyond!

One of the achievements we are most proud of in 2020 was introducing the 'Designate' feature, extending SADIE access to users working on behalf of prescribers. Prescribers told us that this feature was critical to using SADIE, and we listened. This feature helped introduce an even more responsive SADIE 2.0, and the feedback has been great! We also introduced a pilot initiative to send EAP Approval Expiry reminders to a limited number of prescribers, to help ensure patients do not experience a gap in their coverage. The pilot will run through December 2020 and the Ministry will evaluate the outcome of these reminders.


