1. Overview

1.1 Purpose

The purpose of this document is to detail the information and technical requirements needed to prepare for and support Electronic Data Transfer (EDT) components and eSubmit system integration.

1.2 Submission Notes

- Submitted files will be imported into eSubmit after core business hours and confirmation reports will be available the following morning.
- Confirmation reports will be sent back to the originating Claims Submission Number (CSN) that submitted the file. Vendors are expected to maintain submitted files in the event a submission cannot be accessed. Submitted files should also be retained for audit purposes.
- One eSubmit ticket is generated per file submitted.
- The system will validate file upload format (see <u>File Naming Rules</u>). The result will be reported in the e-submission confirmation report.
- If the file name does not match the File Naming Rules convention, the file will be rejected.
- Designees will need to be granted MCEDT permissions for **eSubmit Submission Upload** to be able to upload the new file type.

2. RAI and Supporting Documentation Submission

2.1 Process Outline

Files will be submitted to MCEDT using the new ESU (eSubmit Submission Upload) resource type. A batch process will run nightly, and all files submitted during the day will be processed at that time. Every file that is submitted will then have an eSubmit ticket created for it, and the file will become an attachment to that ticket.

2.2 Technical Specifications

2.2.1 File Naming Rules

The file must have specific metadata included in the filename in the following dash delimited format in order to be successfully processed:

AAA-BBBBBB-CCCC-DD-EE-FFFFFFFFFFFFFFFGGGGGGGGG.zzz

AAA – Document type, SUP or RAI

BBBBBB – Provider number

CCCC – Group number (or "0000" for Solo Provider)

DD – Specialty

EE – Province Code

GGGGGGGG - Account number, variable length up to 8 characters

zzz – File name extension

Example:

SUP-211122-4321-12-ON-1234567890-87654321.pdf

2.2.2 File Content Rules

Submitted files can be of any type except .dll or .exe, and must be 10 megabytes or less in size.

2.2.3 MCEDT File Errors

#	Error Condition	Error Message
1	File Size exceeds maximum allowable file size.	File size exceeds the allowed file size.

3. Submission Response

3.1 Process Outline

After the batch process is run, another batch process will be run to create an eSubmit Submission Confirmation (ESC) report. Each submitted file creates a separate eSubmit ticket containing a system generated ticket number. All submission responses will go back to the CSN that submitted the file.

Designees will need to be granted MCEDT permissions for **eSubmit Submission Confirmation** to download the confirmation reports.

3.1.1 File Layout

The file name will be the CSN of the submitter, followed by "_Confirm_Rpt.csv".

Example:

019988_Confirm_Rpt.csv

The file will be a comma delimited .csv file, with the following fields:

CSN, TICKET TYPE, TICKET NUMBER, SUBMISSION DATE (MM/DD/YYYY), GROUP, SOLO, SPECIALTY, PROVINCE, HEALTH NUMBER, ACCOUNT

3.2 File Errors

If there is an issue with the metadata in the file name of the submitted file, then no eSubmit ticket will be created, and a csv response will be sent back with the filename and error message(s) in the TICKET NUMBER field position within the ESU report.

Example:

CSNTEST06,SUP,(Filename:SUP-211122-4321-12-ON-1234567890-Account.dll) (Invalid Document Type)(Solo Number longer than 6),10/18/2021, 4321,2111222,12,ON,1234567890,Account

If there is a health number error it will display in the TICKET NUMBER field position as part of the file name, but no health number will display after the province code.
