

<b>72041</b> – Acceptance of Gifts	Superseded by the <i>Public Service of Ontario Act, 2006</i> and O.R. 381/07 thereunder.
<b>73041</b> – Retail Sales Tax (RST)	Replaced by Harmonized Sales Tax (HST)
<b>74040</b> – Free Searching Privileges	Interdepartmental accounts are no longer in use.
<b>75080</b> – Land Transfer Tax (LT Tax)	Superseded by <i>Land Transfer Tax Act, 1990</i> . Legislation, information and Tax Bulletins & Guides available on Ministry of Revenue (MOR) Website: <a href="http://www.rev.gov.on.ca/en/tax/ltt/index.html">http://www.rev.gov.on.ca/en/tax/ltt/index.html</a>
<b>77017</b> - Cautions	Superseded by Bulletin 2000-2 and <i>Red Tape Reduction Act, 1998</i> amendments to Cautions.
<b>77018</b> – LT Tax	Superseded by <i>Land Transfer Tax Act, 1990</i> . Legislation, information and Tax Bulletins & Guides available on MOR Website: <a href="http://www.rev.gov.on.ca/en/tax/ltt/index.html">http://www.rev.gov.on.ca/en/tax/ltt/index.html</a> .
<b>78012</b> – <i>Succession Law Reform Act</i> (SLRA)	These provisions are contained in the current version of the SLRA, Bulletins 93002, 2000-5 & 2000-6 and the Electronic Registration Procedures Guide (ERPG).

<b>79016</b> – <i>Succession Duty Act</i>	Repealed by <i>Succession Duty Legislation Repeal Act, 2009</i> .
<b>79019</b> – <i>Conveyancing and Law of Property Act</i>	Paper abstracting procedures where freehold and leasehold interests have merged no longer apply due to automation.
<b>80013</b> – <i>Registry Act</i> Ruling Out	Superseded by deletion procedures contained in Sections 56 and 67 of the <i>Registry Act</i> .
<b>81020</b> – <i>Power Corporation Act</i> Lien & Charge	Sections of this Act that allowed the lien/charge to be registered have been repealed.
<b>82010</b> - Cautions	Superseded by Bulletin 2000-2 and <i>Red Tape Reduction Act, 1998</i> amendments to Cautions.
<b>84008</b> – <i>Construction Lien Act (CLA)</i> Letter of Credit	Letter of Credit is specifically provided for in the CLA.
<b>89008</b> – Cautions	Superseded by Bulletin 2000-2.
<b>91002</b> – RST	Replaced by Harmonized Sales Tax (HST)
