ORDER OF THE DIRECTOR OF TITLES

CONDOMINIUM ACT, 1998 S.O. 1998, c. 19, AS AMENDED.

I, Katherine M. Murray, Director of Titles hereby order that:

- 4. The certificate referenced in subsection 10 (1) of Ontario Regulation 48/01 shall be in the form entitled "Certificate of Registration (Under Clause 11 (1) (a) of Ontario Regulation 49/01 of the *Condominium Act*, 1998)" located on the Government of Ontario website.

The consent referenced in subsection 40 (3) of Ontario Regulation 48/01 shall be in the form entitled "Consent to Attachment of a Common Interest (Schedule B to Declaration for a Common Elements Condominium Corporation) (Under subsection 40 (3) of Ontario Regulation 48/01 and under Clause 140 (c) of the *Condominium Act, 1998*)" located on the Government of Ontario website.
- 10. The certificates referenced in subsections 40 (11) and 56 (7) of Ontario Regulation 48/01 shall be in the form entitled "Certificate of Architect or Engineer (Schedule G to Declaration for a Common Elements or Vacant Land Condominium Corporation) (Under subsections 40 (11) and 56 (7) of Ontario Regulation 48/01 and under Clauses 8 (1) (e) and (h) or Clauses 157 (1) (c) and (e) of the *Condominium Act, 1998*)" located on the Government of Ontario website.
- 11. The consent referenced in clause 52 (2) (f) of Ontario Regulation 48/01 shall be in the form entitled "Consent and Postponement (Amendment to Schedule B to Declaration of a Phased Condominium Corporation to Create a Phase) (Under Clause 52 (2) (f) of Ontario Regulation 48/01 and Clause 146 (4) (a) of the *Condominium Act, 1998*)" located on the Government of Ontario website.
- 12. The certificate referenced in subsection 54 (3) of Ontario Regulation 48/01 shall be in the form entitled "Certificate of Registration of Amendment to Declaration and Description Creating a Phase (Under Clause 54 (3) of Ontario Regulation 48/01 of the *Condominium Act, 1998*)" located on the Government of Ontario website.
- 13. The amendment to description for a Vacant Land Condominium Corporation referenced in subsection 58 (1) of Ontario Regulation 48/01 shall be in the form entitled "Amendment to Description for a Vacant Land Condominium Corporation (Under Clause 158 (3) (b) of the Condominium Act, 1998)" located on the Government of Ontario website.
- 14. The amendment to declaration for a Leasehold Condominium Corporation referenced in section 61 of Ontario Regulation 48/01 shall be in the form entitled "Amendment to Declaration for a Leasehold Condominium Corporation (Under Subsection 174 (8) of the *Condominium Act, 1998*)" located on the Government of Ontario website.

The certificate referenced in subsection 43 (1) of Ontario Regulation 49/01 shall be in the form entitled "Certificate of Owner in the Matter of a Common Elements Condominium Corporation (Schedule I to Declaration) (Under Clause 139 (1) (b) of the *Condominium Act, 1998*)" located on the Government of Ontario website.

The notice referenced in subsection 43 (2) of Ontario Regulation 49/01 shall be in the form entitled "Notice of Attachment of a Common Interest in a Common Elements Condominium Corporation (Schedule J to Declaration) (Under Clause 139 (2) (b) of the *Condominium Act, 1998*)" located on the Government of Ontario website.
