

ORDER OF THE DIRECTOR OF TITLES

Registry Act
R.S.O. 1990, c. R.20, AS AMENDED.

I, Katherine M. Murray, Director of Titles hereby order that:

IN THE MATTER OF the *Registry Act*, R.S.O. 1990, c. R.20 and regarding the name and location of forms under Ontario Regulation 434/11 and Ontario Regulation 43/96:

1. The approval block referenced in subsection 6 (4) of Ontario Regulation 434/11 shall be in the form entitled "Examiner's Approval (Under Section 12 of O. Reg 43/96 of the *Registry Act*)" located on the Government of Ontario website.
2. The certificate referenced in subsection 6 (5) of Ontario Regulation 434/11 shall be in the form entitled "Certificate of Registration (Section 13, Clause 16 (1) (j) or Subsections 27 (3), 36 (2) or 43 (1) of O. Reg. 43/96 under the *Registry Act*)" located on the Government of Ontario website.
3. The receipt referenced in subsection 6 (6) of Ontario Regulation 434/11 shall be in the form entitled "Reference Plan Receipt (Subclause 16 (1) (k) (i) or Clause 20 (1) (c) or 21 (5) (a) of O. Reg. 43/96 under the *Registry Act*)" located on the Government of Ontario website.
4. The requisition referenced in subsection 6 (7) of Ontario Regulation 434/11 shall be in the form entitled "Requisition for Deposit of a Reference Plan (Subclause 16 (1) (k) (ii) or Clause 20 (1) (d) of O. Reg. 43/96 under the *Registry Act*)" located on the Government of Ontario website.
5. The note referenced in subsection 6 (10) of Ontario Regulation 434/11 shall be in the form entitled "Comprising Note (Clause 24 (b) of O. Reg. 43/96 under the *Registry Act*)" located on the Government of Ontario website.
6. The consent referenced in subsection 6 (12) of Ontario Regulation 434/11 shall be in the form entitled "Consent of Chargee or Mortgagee (Clause 25 (1) (b) of O. Reg. 43/96 under the *Registry Act*)" located on the Government of Ontario website.
7. The certificate referenced in subsection 6 (13) of Ontario Regulation 434/11 shall be in the form entitled "Certificate of Clerk and Head of Municipality (Subsection 42 (5) of O. Reg. 43/96 under the *Registry Act*)" located on the Government of Ontario website.
8. The certificate referenced in subsection 6 (15) of Ontario Regulation 434/11 shall be in the form entitled "Certificate of Correction (Subsection 49 (10) of O. Reg. 43/96 under the *Registry Act*)" located on the Government of Ontario website.
9. The certificate referenced in subsection 8 (2) of Ontario Regulation 434/11 shall be in the form entitled "Certificate of Deposit (Under Subsection 108(2) of the *Registry Act*)" located on the Ministry's internal knowledge management website.

This Order comes into effect on the date of filing of the amending regulations for Ontario Regulation 43/96 under the *Registry Act*.
