ORDER OF THE MINISTER OF CONSUMER SERVICES

CONDOMINIUM ACT, 1998

S.O. 1998, c. 19, AS AMENDED

Regarding Forms under Ontario Regulation 48/01 and Ontario Regulation 49/01

I, John Gerretsen, Minister of Consumer Services, hereby order as follows:

A: Ontario Regulation 48/01

- 1. The instrument appointing a proxy to vote at a meeting of owners referenced in section 13 of Ontario Regulation 48/01 may be in one of the following forms that are located on the Government of Ontario website:
 - a) Proxy for General Matters (Under Subsection 52 (6) of the *Condominium Act*, 1998)
 - b) Proxy for General Matters and for the Election of Directors (Under Subsection 52 (6) of the *Condominium Act*, 1998)
 - c) Proxy for General Matters and for the Removal of Directors and Election of Substitutes (Under Subsection 33 (2) Of the *Condominium Act*, 1998)
- 2. The notice referenced in section 24 of Ontario Regulation 48/01 shall be in the form entitled "Notice of Lien to Owner (Under Subsection 85 (4) of the *Condominium Act*, 1998)" located on the Government of Ontario website.
- 3. The notice referenced in section 62, paragraph 1 of Ontario Regulation 48/01 shall be in the form entitled "Notice of Intention to Renew the Leasehold Interests in a Leasehold Condominium Corporation (Under Clause 174 (1) (a) of the *Condominium Act*, 1998)" located on the Government of Ontario website.
- 4. The notice referenced in section 62, paragraph 2 of Ontario Regulation 48/01 shall be in the form entitled "Notice of Intention Not To Renew the Leasehold Interests in a Leasehold Condominium Corporation (Under Clause 174 (1) (b) of the *Condominium Act*, 1998)" located on the Government of Ontario website.
- 5. The notice referenced in section 62, paragraph 3 of Ontario Regulation 48/01 shall be in the form entitled "Notice of Deemed Renewal of Leasehold Interests in a Leasehold Condominium Corporation (Under Subsection 174 (4) of the *Condominium Act, 1998*)" located on the Government of Ontario website.

6. The notice referenced in section 62, paragraph 4 of Ontario Regulation 48/01 shall be in the form entitled "Notice of Non-Renewal of Leasehold Interests in a Leasehold Condominium Corporation (Under Subsection 174 (6) of the *Condominium Act, 1998*)" located on the Government of Ontario website.

B: Ontario Regulation 49/01

- 1. The proof referenced in section 37 of Ontario Regulation 49/01 shall be in the form entitled "Proof of Enrolment in the Ontario New Home Warranties Plan (Subclause 43 (5) (f) (i) of the *Condominium Act*, 1998)" located on the Government of Ontario website.
- 2. The evidence of compliance referenced in section 39 of Ontario Regulation 49/01 shall be a statement that is in the form entitled "Evidence of Compliance (Subsection 81 (6) of the *Condominium Act*, 1998)" located on the Government of Ontario website.
- 3. The certificate referenced in subsection 48 (2) of Ontario Regulation 49/01 shall be in the form entitled "Certificate in the Matter of a Sale (Under Subsection 124 (3) of the *Condominium Act*, 1998)" located on the Government of Ontario website.
